<p><u>MINUTE NO.16.</u> <u>PLANNING PROPOSALS FOR CONSIDERATION</u> <u>(Appendix A)</u> <u>11/01456/FUL – Opposite Vicarage Close, Main Street, Grenoside, Sheffield S35 8PN – Telecommunications Mast</u> The Planning Committee considered the above application to which seven objections had been received by the Committee and there were an additional 18 comments on the City Council website. Residents also attended the meeting at a later time and spoke to the Committee about their concerns and informed the Committee that they would be handing in to the City Council Planning Department a petition with 725 signatures against the proposed telecommunications mast. The Committee are highly disturbed about the proposed application and feel that due to the strength of feeling of the residents, need to support their objections on the following grounds:- Ø The area is within the Grenoside Conservation area and as identified in the Grenoside Conservation Area Appraisal “development proposals will be judged on their effect on the area’s character, setting and appearance”. Therefore the</p>	

overwhelming size and visual appearance of the proposed mast and cabinets would be inappropriate in this area.

- Ø In the Sheffield Unitary Development Plan particular emphasis is made on policy BE17 in relation to developments within and adjacent to the conservation area, which affect the character, setting and appearance of the conservation area. "It will adopt the same approach to the policies set out in the Core Strategy of the Sheffield Development Framework, and emerging Heritage policies and Supplementary Planning documents".
- Ø **Road safety issues** – Main Street is a very busy road and the mast would create a visual obstruction for vehicles entering and leaving the Community Centre car park. The school traffic with an authorised SCC initiated safe route to school, uses this car park. In close proximity to the proposed site are Appletree Nursery, Grenoside School, and the church hall which is attended by a baby and toddler group, and various other groups and the pedestrian crossing which is close by, will have views restricted by the mast and box.
- Ø **Health and safety issues** – residents are concerned about possible thermal and non-thermal effects of radiation.
- Ø **Buildings of Townscape merit** (also described in the Appraisal) Grenoside St Mark's Church and the Church Hall are listed as such buildings and the scale, size and materials proposed for the mast are inappropriate in this area.
- Ø **Key views and vistas** (as described in the Appraisal) these are key to the general street scene of the Conservation Area and the size and scale of the tower will detract from the views of a traditional village.

The Committee requested that the Clerk write to the Head of Planning with their concerns and ask that the decision be made by the Board rather than a delegated officer. They also requested that an extension of the consultation timescale be requested due to the impact of the Bank Holiday period for responses to be made.

11/01426/FUL – Site of Rollem Patent Products Ltd – 80-82 The Common, Sheffield S35 9WN – Aldi Supermarket

The Committee considered the above planning application to which there were 21 comments on the City Council website, 14 in favour of the supermarket and 7 against. Most of the concerns raised were possible increase in noise levels and litter and also that there were other supermarkets in the close proximity.

The comments in favour of the development felt that it would be good to have more choice and competitive prices between the supermarkets. The Committee felt that there would be possible benefits in that there would be an additional parking area for visitors to nearby shops and premises.

The Committee were also aware of comments raised with regard to the pre-seventeenth century buildings and would request that any

<p>the pre-seventeenth century buildings and would request that any future development of the site would incorporate the building by restoring and refurbishing the former mill.</p> <p>One resident attended after the meeting to voice his concerns. He had attended the public meeting held in April and made an objection to the City Council at pre-planning stage. He has requested that air quality monitoring take place and has asked that the decision deadline be put back to the 17 June 2011. He also raised concerns about the loss of trees on the site, which could have an environmental impact on the area. He also raised concerns about the impact of the development on other businesses in the area.</p> <p>Whilst the Committee are in support of the development in principle they requested that a letter be sent to the Head of Planning at Sheffield City Council requesting the need for consideration to be given to the development of the old mill and also traffic management issues.</p> <p><u>11/01505/FUL – 227 The Wheel, Ecclesfield, Sheffield</u></p> <p>The Committee were informed that the above application has now been withdrawn, to which one objection had been received and two objections had been lodged on the City Council website.
